PURPOSE:

The purpose of this policy is to insure that operators of Club owned equipment are properly traine d, qualified, and authorized by Club Officers to operate the equipment.

BACKGROUND:

At the June, 2015 Board of Directors meeting, it was approved that the Club procure a new 30 HP plus tractor and a Zero Turn Mower. Procurement of both pieces of equipment was completed in June and July, 2015. Previously, approximately 4 years prior, a 23 HP Kubota tractor was procured. Also, the Club owns a 1985 Case Backhoe.

EQUIPMENT APPLICABILITY:

- Kubota L 3301 Tractor
- Kubota B 2620 Tractor
- Kubota Z125s Zero Turn Mower (Not to be used on any significant slope, including, but not limited to the hillside adjacent to the Clubhouse and the Archery Walk Thru Range)
- Case Backhoe

POLICY:

Prior to operating equipment, proposed operators shall perform the following under the supervision of a designated Cub Officer (Currently Bill Sellitto, Ed Moody, & Ray Ackerman):

- Review the operating manual
- Understand the capabilities and limitations of the equipment
- Understand fueling requirements
- Understand all equipment control features
- Understand all equipment safety features and interlocks
- Practice in an open area with no obstructions for ½ half hour and demonstrate acceptable knowledge and operation of the specific equipment.
